1. Call to order at 7:51 am by Nicole Boucher. Alyssa Woodfield was unable to attend.
2. Dave verified everyone on the council watched the Trustlands Training video.
3. The Council discussed the Rules of Order and Procedure for the Charter Trust Land Council. Preston Hurst made a motion to accept the Rules of Order and Procedures, Dave seconded it. Everyone voted "Aye" to adopt the rules and procedures.
