A Call to Action:

Creating a Safe Learning Environment for Every Student

With a higher ratio of boys than girls at AMES this year, we have a meaningful opportunity to teach and model healthier ways of expressing identity and coping with challenges. Our goal is for boys to develop respect-based relationship skills and emotional resilience, and for girls to feel safe and supported every day they walk into school.

Recently, we've seen an increase in behaviors among students - particularly boys - that reflect harmful expectations around "being tough," putting others down, or dismissing emotions. These behaviors can start small, disguised as teasing or casual comments, but they can escalate into patterns that marginalize girls and contribute to harassment or unsafe environments.

How Families Can Support This Work

We are asking for your help in reinforcing these expectations:

- Talk openly with your child about respectful behavior, consent, and the impact of words
- Call out harmful comments or actions *especially* when they are played off as "just a joke"
- **Encourage emotional expression** and validate all feelings, not only the "acceptable" ones
- Model empathy and accountability in everyday interactions
- **Partner with us**: reach out to AMES Counselors, Administrators or teachers if you see or hear something concerning

Together, we can set a firm standard: Our school is a place where all students are safe, respected, and free to learn without fear or discomfort.

Thank you for being active partners in shaping a school culture where every student, including our sons, has the skills, confidence, and compassion to thrive.



Scholarship is now open for the 2026-2027 school year! The scholarship covers full tuition and room & board (up to 10 semesters) at the University of Utah. In order to be eligible your student must be an incoming first-year college student,

first-generation (meaning they are the first in their immediate family to attend any amount of college), graduate from a Utah high school, and have a GPA of 2.5 or higher. In order to access the application, your student must be accepted to the University of Utah and use their assigned UNID and password to log in. Mindful Minute

Take a moment today to pause and breathe for one minute. Close your eyes (if safe to do so), inhale slowly through your nose for a count of four, hold for a count of two, then exhale slowly through your mouth for a count of six. As you breathe out, try mentally releasing any worry or tension from your shoulders. Repeat this cycle two more times.

In our busy lives (schoolwork, applications, family, friends, you name it) taking a short moment of mindful breathing can help reset your focus, calm your body, and bring you back to the present. We want to encourage and remind you to pause like this when they feel overwhelmed or stressed.

The 2026-27 FAFSA is officially open at fafsa.gov, this is the key form for accessing federal, state, and college financial aid. The updated application is faster and easier, with new features such as:

***Net worth is the value of the investments, business, or investment farm minus any debts owed against them. Investments include stocks, bonds, mutual funds, 529 plans, secondary or rental properties, etc. Retirement investments are not reported on the FAFSA.

Which parent will need a StudentAid.Gov account to consent and sign the FAFSA form?

Only one parent is required to sign if married/remarried and filing taxes jointly.

If married/remarried but filing taxes separately, BOTH parents must sign.

Parents who are unmarried and living together BOTH must sign.

In the case of divorced or separated parents, the ONE who provides more financial support to the student OR with higher income/assets must sign.

If a parent has remarried, stepparent info is also needed (start from the top).

A widowed parent, not remarried, requires the signature of the surviving parent.

Parent(s) will need:

- □ StudentAid.Gov account username and password
 □ Permanent mailing address
 □ Month/year the parent(s) became a resident of Utah
 Residents have lived in Utah for 12 consecutive months or longer
 □ Parents may need their student's legal first and last name, date of birth, Social Security Number, and
- Parents may need their student's legal first and last name, date of birth, Social Security Number, and email. It is strongly recommended that the student start the form
- Married/remarried parents will need their spouse's legal first and last name, date of birth, Social Security Number. If no SSN, insert their mailing address and email
- 2024 federal tax forms, 1040 form, and all schedules, if applicable
- 2024 income forms, such as a W-2 form from your employer, if applicable
- Assets
 - Current total of cash, checking, or savings accounts
 - □ Net worth of all investments***

 - Amount of child support received in the past year for all children, if applicable



StudentAid.Gov Account Setup





What's needed to create a StudentAid.Gov account?

Account usernames and passwords are required for the student and each parent.

- Name: Full legal name as it appears on your Social Security card.
- 2. Date of Birth
- 3. Social Security Number: Required for those with an SSN. Not required for parents without one.
- 4. Email: Must be verified. Use a non-school email. Students will need access to this email throughout college.
- Mobile Phone/Authenticator App: Optional to download but recommended for login, account recovery, and enhanced security.

Who NEEDS to create a StudentAid.Gov Account?

- Students seeking financial aid.
- ✓ Biological or adoptive parents of dependent students (with or without a Social Security Number). If parents are divorced or separated, only the parent who provides the majority of financial support to the student will need a StudentAid.Gov Account. If that parent is remarried, the stepparent may need one, too.
- Student's spouse, if applicable.

Who should NOT create a StudentAid.Gov Account?

- Parents who already have a StudentAid.Gov Account (parents cannot create a new one).
- X Students without a Social Security Number.
 Cannot file the FAFSA. Please consult a school counselor or college adviser for alternative ways to pay for college, scholarship opportunities, and info on HB 144.
- × Grandparents, foster parents, legal guardians
- × Siblings
- × Aunts, uncles, cousins, etc.

How do I know if my parents need to create an account? What if my parents aren't a part of my life? If students can answer YES to any of the following questions, they do NOT need parental accounts.

- . Will you be 24 years of age or older as of Jan 2025, OR are you married but not separated or divorced?
- Do you have a child or another dependent to whom you provide the majority of financial support?
- Are you currently on active duty, OR are you a veteran of the U.S. Armed Forces?
- · At any time since you turned 13, were you an orphan, in foster care, or a ward of the court?
- · Are or were you ever a legally emancipated minor, as determined by a court?
- Do you have a court-ordered legal guardian who is not your biological or adoptive parent?
- Are you unaccompanied AND either homeless OR self-supporting and at risk of being homeless?
- Do you have an unusual circumstance that prevents you from contacting your parent(s)? Ask for more details.

Important Warning

 The StudentAid.Gov website times out if you're inactive for a short period. You must complete the setup in one session or start over.

Experiencing issues or already have an account and can't log in?

 If you have trouble or can't access your account, call Federal Student Aid at 1-800-433-3243.

Finished?

- Don't forget to save your backup code!
- Processing your identity may take 1-3 business days.
 During this time, you won't be able to transfer IRS tax information to the FAFSA form.

Keep your account information handy for the FAFSA each year. Take a picture or keep it in your wallet.


Is My Parent a **CONTRIBUTOR** When I Fill Out My FAFSA® Form?



A parent means your legal (biological or adoptive) parent or a person that the state has determined to be your legal parent. A stepparent is considered a parent if they have adopted you. Stepparents that have not adopted you will be identified as a parent spouse.





Their individual information, consent and approval, and signatures will be required on the FAFSA form. If your parents filed taxes jointly, only one parent is required as a contributor and will report information for both parents. divorced, or are separated. Their individual information, consent and approval, and signatures will be required on the FAFSA® form.

Has this parent married/remarried?




Your parent's marital status is married/remarried. Your stepparent will also be identified as a contributor on the FAFSA® form if they didn't file their taxes jointly with your parent.

Your parent's marital status is single (never married), separated, divorced, or widowed. An additional parent will not be identified as contributor.

Note: Dependent students are required to report parent information on the FAFSA® form, and in most cases, a parent will be identified as a contributor for these students. All contributors are required to provide their information, signature, and consent and approval to have their federal tax information transferred directly from the IRS into the FAFSA form. Being a contributor on the FAFSA form does not mean an obligation to pay for the student's education.



A PATH TO SUCCESS AT SLCC

SUPPORTING STUDENTS WHO FACE BARRIERS RELATED TO THEIR IMMIGRATION STATUS

CAN UNDOCUMENTED STUDENTS GO TO COLLEGE?

Yes! Admission to Salt Lake Community
College is open to all students regardless of
their immigration status. When asked "Are
you a U.S. citizen?" select "Status Not
Listed." No additional description is
required, and an SSN does not need to be
entered.

WHAT IS HB 144?

HB 144 is a policy that allows qualifying students to pay in-state tuition at a Utah college or university.

The two main requirements are:

- To have attended high school in Utah for **3 or more years**.
- Graduated from a Utah high school.

WHAT CAN I DO WHILE I'M STILL IN HIGH SCHOOL?

If you want to get ahead while still in high school, consider taking Concurrent Enrollment (CE) classes. They are college-level courses that you complete in high school. At only \$5 per credit, you'll get ahead of your studies at a very affordable price!

HOW CAN I ACCESS IN-STATE TUITION?

Students are immediately eligible for in-state tuition for Summer semesters. During Spring and Fall semesters, students can determine if they are eligible for **HB 144** or **HB 102** to lower the tuition rate.

WHAT IS HB 102?

HB 102 is a policy that allows qualifying students to pay in-state tuition at a Utah college or university.

The two main requirements are:

- Have applied or have been approved for a certain immigration status and have an I-797 (Notice of Action) from USCIS.
- Have resided in Utah for 12 consecutive months.

APOYO A ESTUDIANTES QUE ENFRENTAN BARRERAS RELACIONADAS CON SU ESTATUS MIGRATORIO

¿PUEDEN LOS ESTUDIANTES INDOCUMENTADOS IR A LA UNIVERSIDAD?

¡Sí! La admisión a Salt Lake Community College está abierta para todos los estudiantes, sin importar su estatus migratorio. Cuando te pregunten "¿Eres ciudadano de los Estados Unidos?", selecciona "Estatus No Listado." No se requiere ninguna descripción adicional, y no es necesario ingresar un número de Seguro Social (SSN).

¿QUÉ ES HB 144?

HB 144 es una políza que permite a los estudiantes que califican pagar la matrícula como residentes del estado en una universidad o colegio de Utah.

Los dos requisitos principales son:

- Haber asistido a la preparatoria en Utah por 3 años o más.
- Haberse graduado de una preparatoria en Utah.

¿QUÉ PUEDO HACER MIENTRAS TODAVÍA ESTOY EN LA PREPARATORIA?

Si quieres adelantarte mientras todavía estás en la escuela secundaria, considera tomar clases de Inscripción Concurrente (Concurrent Enrollment, CE). Son cursos a nivel universitario que completas en la secundaria. Por solo \$5 por crédito, avanzarás en tus estudios a un precio muy accesible.

¿CÓMO PUEDO ACCEDER A LA MATRÍCULA COMO RESIDENTE DEL ESTADO?

Los estudiantes son elegibles de forma inmediata para la matrícula como residentes del estado durante los semestres de verano. Durante los semestres de primavera y otoño, los estudiantes pueden determinar si son elegibles para HB 144 o HB 102 para reducir el costo de la matrícula.

¿QUÉ ES HB 102?

HB 102 es una políza que permite a estudiantes calificados pagar la matrícula estatal en una universidad o colegio de Utah.

Los dos requisitos principales son:

- Haber solicitado o haber sido aprobado para un estatus migratorio específico y contar con un formulario I-797 (Aviso de Acción) emitido por USCIS.
- Haber residido en Utah durante 12 meses consecutivos.

¿QUÉ RECURSOS ESTÁN DISPONIBLES EN EL CAMPUS?

SLCC ofrece numerosos recursos, pero el SLCC Dream Center está dedicado a ayudar a los estudiantes que enfrentan desafíos debido a su estatus migratorio. Ellos pueden guiarte en el proceso de comenzar en SLCC, solicitar becas y construir una red en el campus.
